This bond act authorizes the State to issue bonds in the aggregate principal amount of \$125 million. The proceeds of the bonds will be used to provide grants to public libraries. The grants will be used to build, equip, and expand public libraries to increase capacity and serve the public.</p> <p style="text-align: center;">INTERPRETIVE STATEMENT</p> <p>Approval of this bond act will allow the State to sell \$125 million in State general obligation bonds. The moneys would have to be used to repair, restore, replace, or preserve the State's natural resources. The moneys may also be used to pay legal or other costs incurred by the State in pursuing its claims.</p> <p style="text-align: center;">INTERPRETIVE STATEMENT</p> <p>This amendment would dedicate moneys collected by the State relating to natural resource damages through settlements or awards for legal claims based on environmental contamination.
