Today Ed McGettigan announced the next step in our continuing effort to take advantage of the internet by increasing the number of documents that can be recorded through our E-Recording Portal. With an additional 11 document types we now allow 58 document types that can be processed through the internet without postage costs or the delay of the mail.

E-Recording in Atlantic County started in June of 2006. Since then we have made continual improvements to the process and the list of documents accepted. In 2013 we accepted over 13,000 documents thru E-Recording which represents over 17% of all documents recorded last year.
