- To vote for the Public Questions, if printed on this ballot, use only a pencil or ink pen (black or blue) and fill in the oval to the right of the word "YES" or "NO".
- If you tear, deface or incorrectly mark this ballot, return it to the Atlantic County Clerk's Election Office and obtain a new ballot.
